

**FIRST AMENDMENT TO HEARTLAND FIRE TRAINING AUTHORITY JOINT
POWERS AGREEMENT ADDING THE CITY OF LEMON GROVE, BONITA-
SUNNYSIDE FIRE PROTECTION DISTRICT, ALPINE FIRE PROTECTION
DISTRICT, REVISING THE TERM AND ALLOCATION OF OPERATION,
MAINTENANCE AND LEASE EXPENSES**

THIS AMENDMENT to the Joint Exercise of Powers Agreement Creating the Agency to be Known as the Heartland Fire Training Authority dated October 4, 1999 (herein referred to as "the Agreement") is made effective July 1, 2010, by and between member agencies City of El Cajon, the City of La Mesa, the City of Santee, City of Lemon Grove, the Lakeside Fire Protection District, San Miguel Consolidated Fire Protection District, Alpine Fire Protection District and Bonita-Sunnyside Fire Protection District.

1. Addition of Members. The preamble to the Agreement is amended to add the City of Lemon Grove, Alpine Fire Protection District and Bonita-Sunnyside Fire Protection District as a Public Agency member of the Heartland Fire Training Authority.

2. Revise Term. Section 2 of the Agreement is amended to read:

This Agreement shall become effective as of the date hereof and shall be binding as set forth in SECTION 9, upon all parties hereto until June 30th, 2020, and shall thereafter continue in full force and effect for ten (10) additional years, or until such time as the Member Agencies agree to terminate the Agreement, in the manner set forth in SECTION 10.

3. Revise Allocation of Operation, Maintenance and Lease Expenses. Section 6 (c) (1) (b) of the Agreement is amended to read:

These expenses shall be shared among the Member Agencies in proportion to the percentage formula recommended by the Board and approved by the Commission, which shall be based upon the average daily staffing of fire suppression personnel. Average daily staffing includes paid suppression personnel, reserve firefighters and the duty chief.

4. Effective Date. This Amendment shall take effect for all purposes on July 1, 2010
